

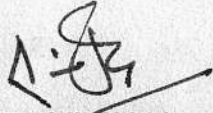

ORDER

The General Administrative Department (GAD), Govt. of NCT of Delhi vide Notification F.No.53/849/GAD/CN/2026/3175-3218 dated 26.05.2026 has changed the date of occasion of Id-ul-Zuha (Bakrid) from 27.05.2026 (Wednesday) to 28.05.2026 (Thursday). Therefore, in pursuance of the provisions of Rule 52 of Delhi Excise Rules, 2010, it is hereby ordered that the Dry Day shall be observed on the occasion of Id-ul-Zuha (Bakrid) on 28.05.2026 (Thursday) in place of 27.05.2026 (Wednesday).
