- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the Service provider of the offered Service. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Provisions for workmen compensation, insurance, public liability, property damage, insurance etc. to be ensured by the contractor. Also, safety measures prescribed for working in Extra High Voltage & use of personnel protective equipment must be adhered to.

3. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

4. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

6. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. The CAMC covers all hardware (servers 44 nos. (IBM/Len ovo make) along with four (4) blade server as per the Bill of material.
- 2. The firm will carry out quarterly preventive maintenance (P M) at the user dept. well in advance w.e.f date of award of the tender.
- 3. In case of breakdown of servers at site, the call for early sol ution should be attended immediately.
- 4. All spares of CAMC are to be entered through challan by th e vendor at the entrance of department at security for the change as per complaint registered by the department.
- 5. In case of replacement of spares, defective spare parts of t he servers are the property of the vendor & the defective pa rts need to be taken back by CAMC vendor immediately agai nst the delivery challan of parts followed by Gate pass issue d by the department.
- 6. The CAMC covers troubleshooting and resolution of issues t hat arise with any of the supplied software/utilities that relat es with an IBM/Lenovo server. In case of malfunction of any storage device, the complete data will be recovered by the firm, and the firm will hand over the recovered data to the de partment immediately without retaining the copy of data with themselves, without charging any extra cost.
- 7. No other payment will be made for the engineer to visit on site/department in case of major issue resolution, if any.
- 8. The CAMC will be comprehensive and the cost of spare part s, if required during the maintenance period will be inclusive in CAMC. Further, un-serviceable parts should be replaced at no extra cost. In case of replacement of the parts in the serv ers, the defective parts are removed from the server to resu me it and the defective part of the server will be the propert y of the firm/vendor.
- 9. The firm will be responsible for providing OS (Operating System), reloading of OS with all the drivers, devi ce drivers, system configuration, and network configuration on the servers during the period of maintenance without fail else necessary penalty will be imposed by the department o n the firm/vendor.
- 10. The estimated project cost of CAMC of the servers may arou

nd 1.5 cr. Accordingly, the performance guarantees of Rs. 7, 50,000/- shall be obtained from the vendor as per latest provisions of GFR (OM no. F.1/2/2023-PPD dated 03.04.2023 issued by Ministry of Finance, GOI)

- 11. The firm will be responsible for providing 99.8% monthly up time for systems.
- A. In cases of downtime beyond those stipulated above, the p enalty of Rs. 5,000/- per hour will be deducted from the paya ble amount.
- B. In case of gross negligence and downtime, security deposit ed by the firm may be forfeited besides immediate cancellati on of the contract.

- 13. The bidder must be a reputed manufacturer(OEM) or his authorized system integrator of the type of products offered. In case of system integrator, a letter of authorization from OEM, specific to the tender should be enclosed. The bids received without authority are liable to be rejected.
- 14. For after sales services the agency shall be availa ble at all times and communication by Tele/E-Mail to agency shall be acknowledged immediately on the same day.
- 15. The bidder shall provide the Registration number

GST/Sales Tax/Service Tax /PAN/TIN- Registration number. O nly local bidders (within Delhi) are allowed to participate in this tender.

- 11. Creating bid for items from irrelevant categories.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
