- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. - 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Provisions for workmen compensation, insurance, public liability, property damage, insurance etc. to be ensured by the contractor. Also, safety measures prescribed for working in Extra High Voltage & use of personnel protective equipment must be adhered to.

#### 3. Buyer Added Bid Specific ATC

- 1) Certificate of Incorporation and Articles of Association of the participants in case of Company/ limited liability partnership agreement in case of LLP/Income Tax Assessment order in case of Proprietorship.
- 2) Firm registration, participant must have registered under service tax registration certificate.
- 3) Authorized partner of M/s IBM for supply of IBM software.

- 6) The estimated project cost of renewal of software licenses may around 1.95 cr. Accordingly, the performance guarantees of Rs. 9,75,000/- shall be obtained from the vendor as per latest provisions of GF R (OM no. F.1/2/2023-PPD datd 03.04.2023 issued by the Ministry of Finance, GOI).

- 7) The renewal of the license should be in the name of Excise, Entt. & Luxury Tax Department, GNC TD.
- 8) IBM active support should be available back to back for the above products supplied by the succ essful bidder in the contract and supporting documents for the same should be provided for releasing of re spective payments.
- 9) The bidder should extend necessary onsite support as and when it is required by the Department .
- 10) Updates/Subscription services: The product update/subscription services should be provided to the Department with rights to IBM product upgrades, maintenance releases and patches released during the ATS period.
- 11) Product Support: IBM product support services to be offered to the department for direct access v ia both the telephone and the web to IBM skilled staff of technical analysts for problem resolution, bug reporting, and technical guidance on a 24x7 basis. This service should be provided through telephone, e-mail and direct connection to IBM web interface without any limitation.
- 12) The bidder has to extend support and carry out all the installation/re-installation and configuration/re-configuration and integration, if required, as per the requirements of application.
- 13) The selected bidder should implement the required patches/ updates at no cost to the Departmen t.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
