Applications are invited for grant of licence in Form L-1F to the wholesellers for supply of Imported Foreign Liquor (including spirits, wine and beer) to the retailers in the National Capital Territory of Delhi for the licensing period 2007-2008 (for a period of Nine months i.e. from 1st July 2007 to 31st March 2007) on the following terms and conditions:

- (i) The licence in Form L-1F shall be granted to a Company; incorporated under the Companies Act, 1956 or a firm registered under the Partnership Act, 1932 or a Co-operative Society registered under the relevant Co-operative Societies Act or a sole proprietor.
- (ii) The licence in Form L-1F shall be granted only to the applicants who are holding a Custom Approved Bonded Warehouse Licence (or having space allocated in the Custom Approved Bonded Warehouse or any other BWH Licencee, subject to submission of NOC from Custom Department).
- (iii) L-1F licence shall be issued on payment of licence fee of Rs. 1,50,000/- only (Rupees one lakh fifty thousand only) for the licensing year 2007-08 (for a period of nine months i.e. from 01st July 2007 to 31st March 2008). The fee may be deposited only after approval/grant of L-1F Licence by the competent authority.
- (iv) Brand registration fee is @ Rs.10,000/- and @ Rs.5,000/- for each brand of Imported Spirit and Wine/Beer respectively for which the applicant of L-1F Licence applies for.
- (v) The L-1F licensee shall be permitted to sell Imported Foreign Liquor (IFL) to the retail vends (L-2F/L-52F), Hotels (L-3F/L-5F), CSD Canteen Stores (L-7F), clubs (L-19F) and Restaurants (L-4F), subject to payment of brand registration fee and licence fee. No imported foreign liquor brands which has not been registered with the Excise Department shall be allowed to be sold to any retail outlet, hotel, club and restaurant.

- (vi) There shall be no restriction on the number of brands to be allowed on one license. However, no exclusive right for marketing any particular brand shall be allowed to any particular licencee.
- (vii) The applicant will have to produce the authorization letter from either IFL brand owning company or from the authorized importer in India for the purpose of registration of any IFL brand.
- (viii) The licence shall be granted in accordance with the Punjab Excise Act, 1914 as extended to the National Capital Territory of Delhi, the Rules made there under and the Circulars/Orders/Directions issued by the Excise Department, Delhi from time to time.
- (ix) Application for grant of L-1F licenses shall have to be submitted in the prescribed form (Annexure-I) along with the other required annexures, to the Collector of Excise, Government of National Capital Territory of Delhi, L-Block, Vikas Bhawan, IP Estate, New Delhi-110002 on any working day.
- (x) The prescribed form for the grant of L-1F licence can be obtained on payment of Rs.500/- (Rupees Five Hundred only) in cash/Demand Draft drawn in favour of The Collector Excise, Delhi., during the office hours on any working day from the single window at the Office of the Commissioner of Excise, Government of National Capital Territory of Delhi, L-Block, Vikas Bhawan, I.P Estate, New Delhi-110002.
