Payment Instructions

1. Payments using SBI cheques can be done at any of the SBI branches.
2. Demand Drafts have to be deposited at the designated SBI Branch at L Block, Vikas Bhawan, IP Estate, New Delhi -110002 only.
3. DD should be drawn in favour of DDO, Excise Entt & LT Deptt, GNCT of Delhi.
4. Two prints of the Challan copy have to be taken and deposited in the bank along with the payment instrument details on or before the challan expiry date.
5. Challans generated before 9:30 AM can be deposited at the bank on the same day or on the next working day. Challans generated between 9:30 AM and 11:30 AM can be deposited after 12:00 noon on the same day or on the next working day. Challans generated between 11:30 AM and 2:30 PM can be deposited after 3:00 PM on the same day or on the next working day. Challans generated after 2:30 PM have to be deposited on the next working day.
6. The bank facilities at IP Estate branch are available from 10 AM to 4 PM on weekdays, 10 AM to 1 PM on Saturdays and not available on public holidays and Sundays.
7. The full amount has to be transferred in one single transaction for a particular request. The amount cannot be divided into multiple payments.
8. A single payment instrument should be deposited against a challan. The amount on cheque/ DD should be same as the total amount on challan. Multiple demand drafts / cheques cannot be deposited against a challan.
9. Upon successful funds transfer, the bank will provide a Treasury Receipt containing a TR5 Number.

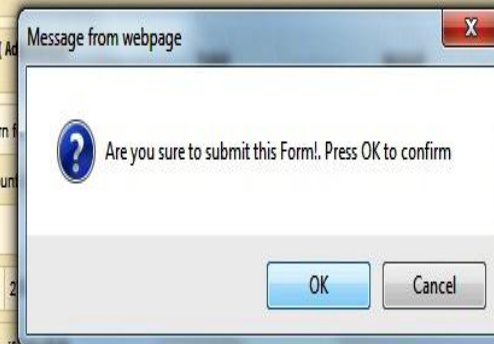

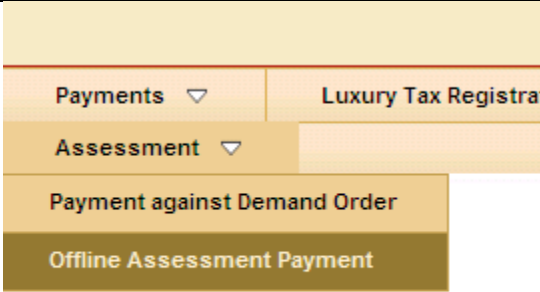
