 - Installation of CCTV cameras systems having coverage of minimum 50 meters and archival period of 30 days in good working condition.
 - j. There is no change in constitution of company/firm. The Directors/Partners/ Proprietor of the company is same.
 - k. The Company/firm is registered with DVAT and Income Tax Department and the due returns have been filed with the concerned authority.
 - The Directors/Partners/Proprietors of the company/firm shall abide by all instructions/orders issued by the Excise Department.
